

TAX LEVY ORDINANCE

TOWNSHIP

ORDINANCE No. 05-12

An ordinance levying taxes for all town purposes for Palatine Township, Cook County, Illinois, for tax year 2012, collectible in 2013.

BE IT ORDAINED by the Board of Trustees of Palatine Township, Cook County, Illinois, as follows:

SECTION 1: That the Supervisor of Palatine Township on December 17, 2012 does hereby determine and declare that the sum of Two Million One Hundred Thirty-Four Thousand One Hundred Eighty-Seven Dollars (\$2,134,187.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as: defined in General Town Fund and General Assistance Fund for the year 2013.

SECTION 2: That the amount levied for each object and purpose shall be as follows:


SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for town purposes for Palatine Township.


