**PUBLIC HEARING ON THE TOWN FUND, GENERAL ASSISTANCE, and CAPITAL
IMPROVEMENT TENTATIVE BUDGETS FOR FISCAL YEAR 2022-2023**

Supervisor Kalkounos stated that the first and only item on the agenda is the Reading of the Notice of Public Hearing of the Tentative Budget and Appropriation Ordinance for the Palatine Township Town Fund, General Assistance, and Capital improvement Funds for Fiscal Year Beginning April 1, 2022, and ending March 31, 2023. He offered background information regarding the Municipal Budget Law requiring that within or before the first quarter of each Fiscal Year, the Palatine Township Board adopts a Budget and Appropriation Ordinance for these three funds. He noted that the Budget Ordinance was prepared in tentative format, and was made available for public inspection since March 25, 2022 at 9:00 a.m. He stated that anyone wishing to address the Board regarding this Ordinance could at this time, but no speakers came forward.
