

TAX LEVY ORDINANCE

ROAD DISTRICT

ORDINANCE NO. 01-07

An ordinance levying taxes for all road purposes for Palatine Township Road District Cook County, Illinois, for the tax year 2007, collectable in 2008.

BE IT ORDAINED by the Board of Trustees of Palatine Township, Cook County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Palatine Township Road District on December 17, 2007 does hereby determine and declare that the sum of Two million five hundred ninety eight thousand and fifty dollars (\$2,598,050) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as: defined in General Road fund for the year 2007.

SECTION 2: That the amount levied for each object and purpose shall be as follows:




SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Palatine Township Road District.


SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
