TAX LEVY ORDINANCE

ORDINANCE No. 03-09

An ordinance levying taxes for all town purposes for Palatine Township, Cook County, Illinois, for the tax year 2009, collectible in 2010.

BE IT ORDAINED by the Board of Trustees of Palatine Township, Cook County, Illinois, as follows:

SECTION 1: That the Supervisor of Palatine Township on December 21, 2009 does hereby determine and declare that the sum of One Million Nine Hundred Nine Thousand Three Hundred Ninety-Two Dollars (\$1,909,392.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as: defined in General Town Fund and General Assistance Fund for the year 2009.
