### **ROAD DISTRICT**

### **ORDINANCE NO. 03-10 RD**

An ordinance levying taxes for all road purposes for Palatine Township Road

District Cook County, Illinois, for the tax year 2010, collectable in 2011.

BE IT ORDAINED by the Board of Trustees of Palatine Township,
Cook County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Palatine Township Road District on December 20, 2010 does hereby determine and declare that the sum of Two million eight hundred and fourteen thousand dollars (\$2,814,000.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:
