

TAX LEVY ORDINANCE
PALATINE TOWNSHIP ROAD DISTRICT
ORDINANCE NO. 07-11 RD

AN ORDINANCE levying taxes for all road purposes for Palatine Township Road District in Cook County, Illinois, for the tax year 2011, collectable in 2012.

BE IT ORDAINED by the Board of Trustees of Palatine Township, Cook County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Palatine Township Road District on December 19, 2011 does hereby determine and declare that the sum of two million eight hundred fourteen thousand dollars (\$2,814,000.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as defined in the General Road Fund for fiscal year 2012.

SECTION 2: That the amount levied for each object and purpose shall be as

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Palatine Township Road District.


SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
