

TAX LEVY ORDINANCE

TOWNSHIP

ORDINANCE No. 6-18

An ordinance levying taxes for all town purposes for Palatine Township, Cook County, Illinois, for tax year 2018, collectible in 2019.

BE IT ORDAINED by the Board of Trustees of Palatine Township, Cook County, Illinois, as follows:

SECTION 1: That the Supervisor of Palatine Township on December 17, 2018 does hereby determine and declare that the sum of Two Million One Hundred Eighty Thousand Five Hundred Sixty-Three Dollars (\$2,180,563.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as: defined in General Town Fund and General Assistance Fund for the year 2018.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

**TRUTH IN TAXATION
CERTIFICATE OF COMPLIANCE FOR ALL COUNTIES
PALATINE TOWNSHIP TOWN FUND & GENERAL ASSISTANCE**

I, the undersigned, hereby certify that I am the presiding officer of, Palatine Township, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

Check one of the choices below:

- 1) The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the Truth in Taxation Law.
- X 2) The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.
- 3) The proposed aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a hearing was not held. The adopted aggregate tax levy exceeded 5% of the prior year's extension and a notice was published within 15 days of its adoption in accordance with the Truth in Taxation Law.
- 4) The adopted levy exceeded the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the Truth in Taxation Law.
