A. Supervisor

i. Project Manager for Window Replacements & Roof Replacement

Administrator Lopez reviewed the COW Packet Insert- Window & Roof Replacement April 21 & 22, 2020 Emails, and JBR Group, LLC Statement of Qualifications. Brent Nakayama, of JBR Group, LLC answered questions from the COW. He clarified that he is not an Energy Efficiency Analyst. He will provide a breakdown of the costs and fees expected for the project in the next few days. ii. GA Office Remodeling Update- 2nd Pay Request

The consensus was for the amount of \$12,841 to be approved for payment at the next Board Meeting. D. Assessor

i. Property Tax Appeal Assessment Update

Assessor Kelly reported that his office handled approximately 350 appeals to date; 300 were via email and 50 through drop-off. He also reported that due to a Cook County system update, the

After this round of appeals, the County will be looking at the assessment values and determining if there is an adverse effect due to the Covid-19 pandemic situation and will consider lowering the assessment amount.

He is working on putting a report together on the status of those cemeteries. He noted positive feedback he had received on the new landscaping company taking care of Hillside Cemetery.
