**PUBLIC HEARING ON THE ROAD DISTRICT TENTATIVE BUDGET FOR FISCAL
YEAR 2023-2024**

Supervisor Kalkounos stated that the first and only item on the agenda is the Reading of the Notice of Public Hearing of the Tentative Budget and Appropriation Ordinance for the Palatine Road District for Fiscal Year Beginning April 1, 2023, and ending March 31, 2023. He offered background information regarding the Municipal Budget Law requiring that within or before the first quarter of each Fiscal Year, the Palatine Township Road District adopts a Budget and Appropriation Ordinance for the Palatine Township Road District.
