NEW TRANSPORTATION BUS



We are excited to announce that Palatine Township has added a new bus to our Transportation Department fleet.

Accessibility to transportation is essential to quality of life. Transportation has consistently been an issue in suburban areas, especially for many seniors and disabled residents. Palatine Township Transportation strives to meet those needs. We give those residents a lifeline to the community, empowering them to remain active and stay connected.

The newly purchased Township bus is larger than the other three in rotation at the Township. With a capacity of either 16 seats plus two-wheelchair accessible or 8 seats and four-wheelchair accessible seating, we can accommodate more individuals that need transportation. If you've seen the bus around town, you'll also notice that it is a vibrant blue.

The Township bus has special meaning. This is a moving tribute, which honors those who ride and those who drive. There are pictures of our actual riders as well as a dedication on the back of the bus.

The memorial on the back of the bus is dedicated to our former bus driver and dear colleague Andy Ostrowski. Andy, who unexpectedly passed in May 2020, was more than a driver. He was family to his coworkers and to his passengers. Andy always had a smile on his face and brought humor and joy to those around him. He is missed by all.

If you are a senior or are disabled resident, please reach out to us if you are in need transportation. Our fleet can transport you anywhere within the Palatine Township boundaries as well as special destinations and with our special shopping trips.

GENERAL ASSISTANCE DEPARTMENT IN TIMES OF CRISIS

In an initiative that was created by the former Palatine Township Supervisor, Sharon Langlotz-Johnson, the Crisis Assistance Program was created to provide resources and funding to the local police departments to assist residents facing an immediate crisis.

Palatine Township's General Assistance Office has partnered with both the Palatine and Rolling Meadows Police Departments to address residents' most critical needs during a crisis situation.

We work in conjunction with the Palatine and Rolling Meadows Police Departments to identify and evaluate individuals and families who are in crisis and are in need of assistance to help alleviate the emergency. Some of the primary necessities that have been identified as crucial during a crisis include access to shelter, food, personal essentials, and transportation.

Most often, these emergencies occur in the evening hours or weekends leaving the individual or families with limited available resources. Many of the residents who have received assistance from the Crisis Assistance Program since its conception in June 2018 have been the victim(s) of domestic violence or a natural disaster occurring in their residence, ultimately leaving the family or individual with no place to turn.

Funds for these emergency needs come from Needy Family Assistance Fund. Combined, we have provided \$7,940 towards hotel stays and have issued over \$4,000 in gift cards for food, personal essentials, and gas to the police departments so they can help individuals during those exact moments of crisis.

ASSESSOR TERRY KELLY, CIAO

ALL PROPERTY TAX EXEMPTION AUTOMATICALLY RENEW IN 2021

Great news for taxpayers regarding your property tax exemptions. In 2021 (tax year 2020), ALL property tax exemptions you received last year in 2020 will automatically renew. This now includes the senior freeze, disabled person and disabled veterans exemption. Your homeowners and senior exemption continues to renew automatically as well. Please note, the returning veteran's exemption will not renew automatically.

You should also note that if you are applying for a senior exemption for the first time you will need to stop by the Assessor's Office and apply. We will need your drivers license.

Property tax exemptions can help you reduce your property tax bill. Currently the senior exemption reduces your homes assessed value by \$8,000, while a homeowner's exemption reduces the value by \$10,000.

ROAD DISTRICT

Aaron Del Mar, Highway Commissioner

FROM THE DESK OF COMMISSIONER DEL MAR

I want to take this opportunity to thank the voters of Palatine Township for my reappointment as the Highway Commissioner. I do not take this position casually or for granted. As Highway Commissioner for the Road District, I have lowered the levy and promised not to raise it while I am in office. I have reduced spending and created capital and infrastructure schedules to ensure proper, fiscal spending. I am excited to continue my work and further the excellent support that Palatine Township Road District offers. Coordinating services throughout the year with surrounding municipalities is a great example of finding cost saving measures and programs. Through intergovernmental agreements, local agencies are effectively and effciently providing quality service to all your infrastructure needs, such as snow and ice removal, pothole patching, or tree trimming. I plan to continue this sharing of knowledge and coordination and expand our supplemental services as well.

I have specific responsibilities for unincorporated areas but believe that all the residents of the Township should benefit from the Road District. We will continue with popular programs such as our annual yard waste collection for the unincorporated areas. The yard waste is processed and allowed to age for a year, turned, and watered to aid the aerobic breakdown of the organic material into compost. Once the compost has cooled, we make it available for anyone living or working within the Township. During the autumn months, stockpiles will appear at the Town Hall at the corner of Quentin and Illinois, and at the material yard on Smith Street. Keep your eyes open as this product moves quickly and is limited in supply. Another green project that is provided to all the residents of Palatine Township is our tire amnesty program. On Earth Day, we collected over 300 tires from the residents of Palatine Township. By disposing of unwanted tires, we can eliminate breeding grounds for mosquitoes, diseases, and unsightly landscape along the roadway. We remained focused on green initiatives and ask for input on new programs that might benefit our community.



Currently, we are in the process of coordinating, bidding, and scheduling the resurfacing of the northern roadways within the Fielding Place Subdivision. As in years and paving projects past, we survey the roadways for drainage concerns and work to make any corrections needed to ensure positive drainage. Once the improvements have been made, we will return to install new high intensity prismatic traffc signs to provide better retro-reflectivity of sight. Finally, to keep our roadways fully maintained and functional, permits are necessary for any home or driveway improvement. Permits are free of charge and easy to complete. We use the permits, certificate of insurance and surety bond to document contractors and hold them accountable for any accidental damage that may occur within the roadway right of way. This information can be accessed through our website, roaddistrict.com.

Once again, thank you for your continued support in my confirmation as Highway Commissioner. I will continue to ensure that Palatine Township Road District is available for all your infrastructure concerns, and with my hard working and knowledgeable staff, we will strive to meet your expectations. Group photos were taken, and cake and coffee were served.



Palatine and Rolling Meadows are the only two municipalities that are having events in Palatine Township. Palatine's is downsized. Rolling Meadows is the same as past years. Arlington Heights and Hoffman Estates have both cancelled their festivals.

Rolling Meadows will have all of their celebrations on Sunday, July 4th. Their parade kicks off at 11:30 AM and will follow the Meadow Drive parade route. The fireworks display goes off at dusk at the Community Center at 3705 Pheasant Drive. Rolling Meadows used some of the money that they didn't use in last year's festival to expand this year's fireworks program.

This year, the Palatine Fest will take place at Community Park on July 1st through July 5th with a full carnival throughout the event as well as an art, craft, and business expo on Saturday, July 3rd and Sunday, July 4th. The fest will also feature live music and a community showcase of entertainment, food and beverage offerings, a bags tournament, scavenger hunt, and Family Day activities on Monday July 5th.
