GENERAL ASSISTANCE DEPARTMENT

CEDA HOME ENERGY ASSISTANCE PROGRAMS

Colder weather means higher energy bills because it takes more energy to heat your home when the temperature drops. With energy costs on the rise, this hurts vulnerable populations and households who are fixed-income, low-income, those with serious medical conditions, and many others.

If you or someone you know is struggling with their energy bills, CEDA's Utility Assistance Programs can help to alleviate the burden of those higher energy costs by providing help with gas and electric bills in addition to fixing or replacing your heating system.

CEDA's Low Income Home Energy Assistance Program (LIHEAP) provides heat and electricity assistance to income-eligible households with energy services during the winter months through the DVP and PIPP programs.

DVP (Direct Vendor Payment) applies a one-time payment directly to the utility company for one or both of the household's energy bills for heating and electric during the program year.

While there will be no new PIPP (Percentage of Income Payment Plan) enrollments this program year, those who are active PIPP recipients may still recertify.

Program Year 24 begins October 2, 2023 and will run through August 15, 2024 unless funds exhaust sooner. There will be two priority periods where only select households will be able to apply before the program is open to all eligible households on December 1.

Priority Group 1 starts October 2 for households with a senior (60+), person(s) with a disability, and families with children under age of six. Priority Group 2 starts November 1 for households disconnected from one or both utilities or in danger of disconnection from one or both utilities.

Please call the General Assistance office at 847-358-6110 to inquire about eligibility, the list of documents needed to apply, and to schedule your LIHEAP appointment. Applications completed by appointment only.

THANKSGIVING OUTREACH PROGRAM

Our Thanksgiving Basket program helped over 1,000 underresourced families in our community last year. Our goal is to provide a similar number of baskets this year. Your generous donations will help provide families all of the ingredients needed to prepare a traditional Thanksgiving dinner. If you would like to help a local family in need, please register on our website. Please contact us no later than November 6, 2023 so that we can estimate how many families we will be able to help.

The suggested basket contents are listed below, but feel free to add a card, note or other non–perishable food items.

- Coffee, Tea or Hot Chocolate
- Cranberry Sauce (1 can)
- Cream of Mushroom Soup (2 cans)
- Cake or brownie mix (up to 2 boxes)

- Fruit (2 cans)
- Instant Mashed Potatoes (1 large box)
- Jell-O (2 boxes)
- Piecrust Mix & Pie Filling (1 cans)
- Stuffing Mix (1 bag)
- Sweet Potatoes (2 large can)
- Turkey Gravy (2 cans) Other optional food items: Cereal

If you are interested in donating a basket, please drop off your donations to Palatine Township between November 6 and November 16. We ask our donors not to include perishables



or frozen turkeys in the baskets. Instead, a \$25 grocery store gift card would be appreciated to enable families to purchase a turkey and other perishable items for their meal. Gift cards can be handed to our volunteers and staff to ensure each family receives one.

Volunteers are needed for sorting donations the weeks of November 6 – 10 and November 13 – 17. We will also need volunteers on November 18 for distribution of Thanksgiving baskets.

ADOPT-A-FAMILY PROGRAM

There are many families in our community whose financial situations will not allow them to experience a joy-filled holiday season. You can reach out and help one of these families by "adopting" them for the holidays. Register as a donor on our website by November 1. Gifts will be collected and distributed to the families on December 9.

CONTINUING TO EXPAND OUR SERVICES

If you qualify for Illinois' Benefit Access Program, you are eligible for free Township bus rides. Documentation must be provided to qualify. (Benefit Access does not apply to the T.R.I.P. bus service.)

We've added to our out-of-township destinations: Lake Zurich and Schaumburg Secretary of State Offices

Palatine Township's transportation service is for all senior residents, ages 60 years and older and permanently disabled residents ages 18 and older. Our bus service provides reliable, lift equipped, curb-to-curb transport to appointments or errands anywhere in Palatine Township plus medical appointments in Arlington Heights. This service is available Monday through Friday.

PALATINE TOWNSHIP ROAD DISTRICT

FROM THE DESK OF COMMISSIONER DEL MAR

Part of the allure of the season that many in the Midwest have come to reminisce, is the smell of burning leaves broadcasting through the countryside. However, burning leaves and other

landscape materials



are regulated through local municipalities. They have the authority to impose restrictions on burning landscape waste such as limiting the hours when such burning may occur, types of material allowed, as well as a total ban of open burning. Please check with your local community before burning. Information can be found on our website, www.roaddistrict.com/public-aware.

Through autumn, specifically November 22, we will continue our annual yard waste collection to process into compost. Currently, we do have material available from late last year's collection and is offered to anyone within the Township for pick-up at the Road District Garage and Town Hall locations. This is a great opportunity to winterize your garden beds. Call for availability, as this material is quickly consumed during the autumn months.

The last two winters we received 34.8 and 20.2 inches of snow.



A typical winter sees 38.4 inches. However, past winters have been a story of mixed precipitation. Palatine Township Road District is staffed and equipped to combat the diverse weather of the Chicagoland area. We continually monitor weather

conditions and apply the best technique to battle inclement weather. For instance, on a sunny, cold morning you may see our trucks anti-icing the roadways with salt brine before a winter storm approaches. This pre-treatment forms a barrier between the roadway and frozen precipitation, preventing an icy bond from forming between the two.

as you face your home. This will reduce the amount of snow deposited into your driveway during the following storm event. If a mailbox has been compromised by our municipal plow truck, please notify us immediately so that a temporary mailbox may be installed for continued postal service. Everyone at the Road District greatly appreciates your effort in combating the winter storms and together we will keep the roadways open and safe. Also, keep track of weather conditions by having multiple ways of receiving alerts. We maintain our website and Facebook pages with information pertaining to the weather, our services, permitting, and upcoming and completed projects.

During the middle of the winter season, we will collect pine trees and holiday decorations that have outlasted the Christmas and New Year Holidays. Incorporated areas, please check with your local waste disposal carrier, as they will collect your trees, usually as part of your service. If you live in the unincorporated areas and it is time for disposal, please place your tree without a bag and trunk side to the curb. There is not a set schedule for pick up, as our focus is on snow and ice control. However, when weather permits, we will collect them, process, and add the spoils to the composting material.

We will continue to ensure that Palatine Township Road District will be available for all your infrastructure concerns and strive to meet your expectations. ASSESSOR'S OFFICE DISABLED VETERANS EXEMPTIONS

With Veterans Day approaching, I wanted to remind all those who have served our country of one of the exemptions that is available to them. If you are a disabled U.S. military veteran, you may qualify for a property tax exemption.

To qualify for this exemption, the owner must use the property as their principal residence, be liable for the property taxes, and be a veteran with a disability. The exemption amount carries over for a surviving spouse of a disabled veteran provided that they hold legal title to the property and do not remarry. The exemption amount carries over for the surviving spouse to a new residence if they use the property as their primary residence and do not remarry.

The Veterans with Disabilities Exemption is for veterans with a service-connected disability that has been certified by the U.S. Department of Veterans Affairs. The VA will determine the extent of your disability and your Estimated Market Value or EAV will be reduced by the amount associated with the degree of your disability.

To calculate your EAV, we take the market value of your home and multiply that by 10% to get your home's assessed value. Once we have the assessed value, we multiply that times the

equalization factor set by the state.

Home Market Value \$250,000, \$250,000 x 10% = \$25,000

EAV = \$25,000 x Equalization Factor for 2022 (3.0027)

EAV=\$75,068

Assessed Value

Once we determine your EAV, the dollar amount associated with your disability is deducted from the EAV. The deductions are:

30 - 49% disabled - EAV reduced by \$2,500

50 - 69% disabled - EAV will be reduced by \$5,000

70% or more disabled - Total Exemption.

UNINCORPORATED ELECTRIC AGGREGATION PROGRAM ENDS

The Palatine Township Board received fixed rate offers via a blind competitive bid process to renew its electric aggregation program which expires at meter read dates in October 2023. Three suppliers responded. The lowest bid received was 7.25¢ per kWh, offering no guarantee of savings for residents. To find out the current ComEd rate go to www.llagg.com/comedrate

Because no offer was accepted, all ratepayers will receive a notice in September from ComEd, a "Confirmation of Change in Electric Supplier," informing of their switch back to ComEd default supply service. No further action need be taken.

Beware: As solicitors learn of the end of the program, aggressive marketing tactics may be employed via mail, phone, text, or door-to-door callers in the community. It is never advised to reveal your ComEd account number to any solicitor, nor to authorize switching of your account until you understand all charges, terms, and conditions of any rates, variable rates, or added fees.
