

**TAX LEVY ORDINANCE**  
**PALATINE TOWNSHIP ROAD DISTRICT**  
**ORDINANCE NO. 03-23 RD**

**AN ORDINANCE** levying taxes by Palatine Township Road District, Cook County, Illinois, for the Tax Year 2023, collecting in 2024, and funding the Fiscal Year 2025, beginning April 1, 2024, and ending March 31, 2025, for the jurisdictional maintenance of the public right of way.

**BE IT ORDAINED** by the Board of Trustees of Palatine Township, Cook County, Illinois, as follows:

**SECTION 1:** That the Highway Commissioner of Palatine Township Road District on October 23, 2023, does hereby determine and declare that the sum of two million, two hundred and five thousand dollars (\$2,205,000.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as defined in the General Road Fund for the Fiscal Year 2025.

**SECTION 2:** That the amount levied for each object and purpose shall be as follows:

**SECTION 3:** That the Town Clerk shall file with the Cook County Clerk, on or before the last Tuesday of December, a duly certified copy of this ordinance.



**SECTION 6:** That this ordinance shall be in full force and effect after its adoption, as provided by law.

**TRUTH IN TAXATION**  
**CERTIFICATE OF COMPLIANCE FOR ALL COUNTIES**  
**PALATINE TOWNSHIP ROAD DISTRICT**

I, the undersigned, duly elected, Supervisor hereby certify that I am the presiding, financial officer, of Palatine Township Road District, and as such presiding officer, I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Property Tax Code, Division 2, the Truth in Taxation Law.

- The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the Truth in Taxation Law.
- The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.
- The proposed aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a hearing was not held. The adopted aggregate tax levy exceeded 5% of the prior year's extension and a notice was published within 15 days of its adoption in accordance with the Truth in Taxation Law.
- The adopted levy exceeded the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the Truth in Taxation Law.
